UAF CRCD ONLINE HEALTH PATHWAYS PROJECT IS THRIVING, WITH PD SESSION PLANNED FOR MAY 1-2



The Online Health Pathways
Courses
project, supported by the
Carl Perkins grant via UAF
CRCD, is entering its third
year. One of the main goals of
this project is to develop a
sustainable sequence of online
asynchronous health courses to

be delivered to rural Alaskan students. One thing they have learned, UAF CRCD faculty Natalia Zinger reports, is that recruiting, training and supporting the professional growth of instructors has been critical to their success. For that reason, they have developed an "internal instructors" professional development system for training and support. Before the courses were developed, each instructor went through online orientation and a "crash course" in methods, pedagogy and technology for successful course delivery and communicating with students. Today, they continue to support these teachers, and help them maintain and manage the courses at a high level of quality. Two years ago, they held the first f2f PD workshop/seminar in Fairbanks, which was tremendously successful and had a great impact on teaching and learning for the project.

On May 1st-2nd, another PD workshop/seminar is being held, attuned to instructors' increased experience and professional growth, and all participants and trainers are coming with the anticipation of intensive, productive work. Instructors will meet with the Executive Dean of College of Rural and Community Development, Peter Pinney. The introductory round table discussion will include FERPA and other regulations for CTE and dual credit teaching. Two other sessions will comprise individual work with specialized training delivered by the UAF eLearning web designers, and with UAF OIT staff regarding the training in latest version of the Blackboard. Both tech-oriented training sessions will also include a broad review of up-to-date tools and methods in online teaching and learning.

FEA WRAPS UP ON A HIGH NOTE

Jan Littlebear of the Alaska Statewide Mentor Project was pleased to share that Future Educators of Alaska (FEA) just completed a successful year of online dual credit education classes, leadership training, and career awareness at UAS in Juneau. Approximately 30 students and advisors from across the state participated in the Career & Technical Student Organization in Anchorage in mid-March where leadership skills were demonstrated as students shared lessons for teaching younger students, creating original books, and public speaking. Close to 60 FEA students then participated in online coursework preparing them for college and careers in education, with a half a dozen students now ready to take the ParaPro Praxis in order to be a certified paraprofessional in their villages. And, finally, the students who received a UAS campus tour, and hands-on science lessons, alongside resume

building and mock interviews walked away from that experience saying it was the highlight of their year. They were excited to be returning to their villages and looking forward to attending college somewhere in Alaska. According to Jan, it was a great year! Congratulations to FEA!

As the school year comes to a close, thoughts for Career and Technical Education for the state of Alaska turn to next year. The Spring Work Session held in early March in Anchorage was deemed successful by attendees, and EED would like to build on the momentum and

collaboration from this event. Discussion of exemplar programs and courses has started with great input and ideas from our district partners. The discussions of setting a "level of expectation" for students to progress in a given pathway were very insightful and gave EED feedback on the activities and actions our partners are taking to raise the bar for CTE in the state. The regional discussions addressed critical issues such as logistics of delivery, best practices and partner engagement are a concern of many partners. The dialogue has started to address these concerns in a more collaborative approach regional needs with a group effort to support the CTE efforts across the entire state. We feel that valuable conversations are taking place and want to approach these issues as building blocks in a group effort to support CTE in your regions and communities. EED is looking to offer leadership and support with best practices and resources to provide quality instruction and training to individuals in the classroom and field.

With this in mind, EED is looking to serve our partners in these endeavors by providing professional development activities and technical assistance in areas of high need and demand. EED anticipates that 2015-2016 academic year is going to be a year of "collaboration and advancement" in CTE across the state. With the impending Perkins reauthorization and the Workforce Investment Opportunities Act (WIOA) going into effect, priority industries and pathways will become a main focus in delivering CTE options to our participants. EED, along with our partners in the Division of Labor and Workforce Development and University of Alaska System, will continue to work together to offer support to our districts for our students to seek opportunities upon graduation to pursue their career goals. My team members and I look forward to continued service and support to our partners to meet their needs and goals for the upcoming academic year and beyond.
